MERIT INCREASES ARE GIVEN ON AN ANNUAL BASIS AND ARE SUPPORTED BY A WRITTEN EVALUATION. PROCESS FOR CEO/PRESIDENT: THE SALARY FOR A NEW CEO/PRESIDENT WOULD BE SET BY THE BOARD OF DIRECTORS. THE BOARD COMPLETES AN ANNUAL REVIEW OF THE CEO/PRESIDENT AND APPROVES AN INCREASE WHICH MIRRORS THE RANGE OF STAFF INCREASE. THE BOARD ALSO COMPLETES A DUE DILIGENCE PROCESS OF COMPARABLE ORGANIZATIONS.
